- 1. Construction continues in dorms. They've been working 7 AM to at least 9 PM and, thank God, our neighbors are being cordial about the racket so far. The chief engineer and the director of a cooperative they've hired workers from have. told me that they'll work through Saturday and Sunday, too. Their priorities, according to the line construction staff (as opposed to the nachalstvo), are to complete two doubles and the kitchen equipment ASAP, but the projected date (acc to a worker) is 7 February at the earliest.
- 2. Re: construction price. The glavnii engineer showed me the protocol you signed on New Year's Eve and, as you know, there was an open-ended clause about final costs to be paid upon receipt of the final smet'. The engineer explained that the cost estimate of R10,200 came from him and the cooperative's director's based on certain unforeseen increases in materials and especially due to the fact that they discovered that the walls through which they had to punch doors were metal-reinforced concrete and not the wooden walls they expected (I vouch for that; I've seen the walls laid open), so they had t bring in a compressor and special crew to work it. That part makes some sense, bul

but I asked don't they have plans, blueprints and they said the Party people had
taken them with them whe tey left. They have floor plans, but not structural
details. I noted that they'd rebuilt the 4th floor andthey must have known abou
t the concrete walls. He explained that they now realize the building is built
in a certain kind of Soviet construction whereby the building's outer frame is
concrete and MOST of the floors ar wooden with wooden internal walls, but, for
structural integrity, every THIRD floor is concrete as are its dividing internal
walls (thus floors 3,6 and 9 are concrete; the FOURTH was wood, so they didn't
know). Just our luck. I found his explanation credible, alas.

Nevertheless, I pointed out that the dollar has risen to R600 (!) since our discussions and that they've been spending RUBLES, so the price should be coming down, not going up. He recalculated on the spot and said that his estimate of 10,200 would now be worth about \$7,000 and asked if that was OK. I gave him a speech about how, while we hve dollars, we're a struggling institution wit dollars.

expenses, so we're not as rich as they think. He countered with "You'd pay that much for construction in the States," and I replied that this project was budgeted for Russian conditions and the construction, after all, i being done under Russian conditions. He agreed, backed off and said he'd get us a full acctg.

- 4. Starostin and Kior tell me they're on top of the lbrary sitation and that it isn;'t worth worryin about. More to follow. Our first teleport bill came in, but I haven't seen it yet. Will advise. No fax bills yet.

More later. Your fax to the rector hadn't been seen by him yeat this moning, but I'm sure it will genrate another round of heated discussons.
