The purpose of these two-day workshops is to provide an opportunity for participants in a variety of disciplines to explore intensively with an internationally recognized leader and their peers a specific area that relates to the Holocaust and/or previous and on-going genocides of all other peoples. Ultimately, the goal of the workshop process is to contribute toward the development of an inter-disciplinary process towards preventing, as much as possible, future recurrences of such tragedies.

Listed below are the names of the workshop leaders, a brief introduction to the leader, the title of the workshop and a brief note on its content and orientation.

Registration in each workshop is limited to forty participants, so please fill out the attached Registration Form as soon as possible. **Pre-registration is necessary**, and will be completed on a first-requested, first-served basis.

The two-day program of Intensive Dialogue Workshops will be opened by a Plenary Session with ELIE WIESEL. In the evening of the first day, there will be a wine-and-cheese reception which will bring together informally the leaders and participants in all the workshops. At the conclusion of the workshops the following day, there will be a concluding Plenary Session with ELIE WIESEL.

WORKSHOP LEADERS

Workshop 1 :

YEHUDA BAUER, Ph.D.

JEWISH-GENTILE RELATIONSHIPS IN NAZI-OCCUPIED EUROPE

Development of the relations between Jews and their non-Jewish neighbors, preceding and during the war, including Polish-Jewish, German-Jewish, and French-Jewish relations, also the attitude of the Churches and the underground resistance movements.

Yehuda Bauer is widely known and warmly regarded as a leading scholar and educator of the Holocaust. He is currently Professor of Holocaust Studies and Head of the Division of Holocaust Studies at the Institute of Contemporary Jewry at the Hebrew University in Jerusalem, of which he is past Head. Born in Prague, Czechoslovakia, he is a graduate of the Hebrew University and Cardiff University College; he is a member of Kibbutz Shoval.

Workshop 2 :

BEN WHITAKER

GENOCIDE, REAL AND POTENTIAL: MINORITY GROUP RIGHTS

A realistic assessment of ongoing genocide in the world today, and of the potential for new acts of genocide around the globe. The workshops will analyze, in particular, the status of minority groups around the world and the system of interrelationships with ruling or dominant peoples and states to whom their fates are tied.

Ben Whitaker has won world-wide respect for his initiative and leadership in the fields of minority and human rights. Since 1971 he has been Director of the Minority Rights Group in London. He is also United Kingdom member of the UN Human Rights Sub-Commission. He is formerly a member of Parliament, and a Lecturer in Law at London University.

Workshop 3 :

ALAN DERSHOWITZ, J.D.

THE ROLE OF LAW IN COMBATTING GENOCIDE

An advocacy session — devoted to both international and domestic law, and to governmental and non-governmental organizational processes. The workshop will consider both theoretical and practical applications of emerging legal principles, doctrine and experience.

Alan Dershowitz is recognized for his scholarship and humanity as one of the outstanding jurists and human rights lawyers in the United States and the world. He is Professor of Law at Harvard University.

Workshop 4 :

FRANK REYNOLDS

THE PERFORMANCE OF THE MEDIA DURING THE HOLOCAUST: LESSONS FOR CONTEMPORARY AND FUTURE SITUATIONS

Practicing journalists and academics in the field of communications are invited to this workshop to review the performance of the media during the Holocaust, and try to apply the lessons of that experience to contemporary and future situations. Modern developments in technology will be analyzed, especially television as an instrument in communicating news and its meaning in the modern world.

Frank Reynolds, Washington anchor man for ABC's "World News Tonight" is one of the U.S.' most respected news broadcasters. He is a veteran of over thirty years in broadcast news; and has also been anchorman for numerous religious and cultural programs, documentaries, and special events. His assignments have included every major news event since 1965.

Workshop 5 :

SAUL MENDLOVITZ, J.D.

A WORLD PERSPECTIVE OF GENOCIDE

A world order perspective of genocide involves the creation of positive value-system momentums towards peace and justice on a trans-national scale. This workshop will explore the elimination of genocide through international community processes that aim, generally, at a global transformation for a more just world order, and will include serious consideration of the appropriate sovereignty of states.

Saul Mendlovitz is Ira D. Wallach Professor of World Order Studies at Columbia University and Professor of International Law at Rutgers University. Currently Vice-Chairman of the Board of the Institute for World Order in New York, and formerly its President, he has stewarded the Institute to a preeminent position in international projects for peace. He is the editor of Alternatives.

Workshop 6 :

LAURIE S. WISEBERG, Ph.D.

THE RESPONSES OF GOVERNMENTS, INTER-GOVERNMENTAL ORGANIZATIONS, AND NON-GOVERNMENTAL ORGANIZATIONS TO GENOCIDE

The workshop will explore, compare and contrast responses to genocidal situations by governments, inter-governmental and non-governmental organizations. When have governments remained silent and when have they acted and why? What international procedures exist for responding to genocide? Can they be effective, and if not, why not? What role can non-governmental organizations play in alerting the world to genocide and halting such processes?

Laurie Wiseberg, Executive Director of Human Rights Internet in Washington, D.C., and Co-Editor of the Human Rights Internet Reporter, has developed the Internet into the leading center and clearing house for human rights information in the world today. A Canadian political scientist, she has taught at the University College of Swansea (Wales), Ahmadu Bello University in Nigeria, and University of Illinois in Chicago.

Workshop 7 :

REV. FRANKLIN H. LITTELL, Ph.D.

TEACHING THE HOLOCAUST AND GENOCIDE

The Holocaust was carried out by educated men and was also an event at the heart of Christendom. How do we teach the facts and truths of the Holocaust and the genocides of all peoples — past and future — in a way that will have a real impact on knowledge, truth and action?

Participants in this workshop will share information on teaching programs, techniques, materials and tools, and will examine resistances to learning about the Holocaust and genocide.

Franklin Littell, Professor at Temple University's innovative Department of Religion, has been the moving force behind more than seventy-five conferences on the Holocaust in cities across the United States, and has amassed a great deal of experience in confronting resistances to Holocaust education by anti-semitic and other anti-humanistic pressure groups, including those who claim, "There is no real proof that the Holocaust actually did happen." He is the Chairperson of the National Institute on the Holocaust. At Temple University he has founded the first graduate program in America leading to a Ph. D. with a major in Holocaust studies. He is the editor of The German Phoenix (1960); The Crucifixion of the Jews (1975); and co-editor of The German Church Struggle and the Holocaust (1974).

Workshop 8 :

SHAMAI DAVIDSON, M.D.

PSYCHOLOGICAL ISSUES IN THE LIVES OF SURVIVORS AND THEIR FAMILIES

The treatment of traumatized and persecuted people, the special requirements of psychotherapy and counseling with Holocaust survivors, their families, and children in individual and group settings.

Shamai Davidson is highly regarded as a pioneer in the conceptualization of the special problems of Holocaust survivors and their families. He is a British and Israeli trained psychiatrist and psychoanalyst, currently Director of the Shalvata Mental Health Center (Tel Aviv University School of Medicine) and Professor of Holocaust and Social Trauma Studies at Bar Ilan University.

Workshop 9 :

ROBERT J. LIFTON, M.D.

PSYCHOHISTORICAL ASPECTS OF THE HOLOCAUST AND GENOCIDE

The role of the Nazi doctors in the Holocaust will be considered in its own right, and from the point of view of a broader analysis of the psychological and historical processes involved in mass murder. Collective psychic processes such as psychic numbing, the pursuit of immortality, and omnipotent aspects of power will be studied.

Robert Lifton, Foundations' Fund Professor of Psychiatry at Yale University, is world renowned for his explorations of the psychology of man's capacity for evil. He is most recently author of The Broken Connection: On Death and the Continuity of Life. His earlier works include studies of returning Vietnam veterans, and the survivors of the atomic bombing (Death in Life: Survivors of Hiroshima).

Workshop 10 :

JOHN SOMERVILLE, Ph.D., Lit. D. and SHINGO SHIBATA

**NUCLEAR WEAPONRY & ECOCIDAL TECHNOLOGY:
THE EXTENSION OF THE THREAT OF THE HOLOCAUST & GENOCIDE TO ALL HUMANKIND**

Nuclear weaponry and ecocidal technology extend the threat of Holocaust and genocide to humankind as a whole. Auschwitz and Hiroshima are universal symbols that define our supreme moral problem. We must prevent Hiroshima in order to live at all ; we must prevent Auschwitz in order to live and make life worth living. The understanding, prediction and prevention that we need must apply to both.

John Somerville and Shingo Shibata are in the forefront of many American-Japanese and International initiatives to prevent atomic destruction.

John Somerville, Professor Emeritus of Philosophy, City University of New York, is co-founder and President of the American Section of the Union of American and Japanese Professionals Against Nuclear Omnicide. He is consultant to UNESCO, and is the author of The Philosophy of Peace, with an Introduction by Albert Einstein.

Shingo Shibata, Professor of Philosophy and Sociology at the University of Hiroshima, is Co-Founder of the Union of American and Japanese Professionals Against Nuclear Omnicide, and author of many works on the world significance of the atomic bombing of Hiroshima and Nagasaki.

Workshop 11 :

RABBI MARC H. TANENBAUM

**DEHUMANIZATION AS A PRELUDE TO GENOCIDE:
DEVELOPING AN EARLY WARNING SYSTEM**

Two questions will be explored:

1. How does the demonic legacy of dehumanization by the Nazis contribute to subsequent dehumanization? There is today an epidemic of dehumanization in many parts of the world — Cambodia, Uganda, Somalia, Libya, to mention just a few.
2. What can we do to construct an early warning system to alert society in time to combat genocidal attacks against groups caught in the midst of social, religious, tribal conflicts?

Marc Tanenbaum, National Inter-religious Affairs Director of the American Jewish Committee, has been described by New York Magazine as an "outstanding Jewish ecumenical leader in the world today." Most recently he has achieved international recognition for his participation in international rescue efforts on behalf of the Vietnam boat people and Cambodian refugees.

Workshop 12 :

SIDRA EZRACHI, Ph. D. and JOHN FELSTINER, Ph. D.

**CREATION IN THE SHADOW OF CATASTROPHE:
THE ARTISTIC RESPONSE TO THE HOLOCAUST**

We will examine the imaginative response to the Holocaust in literature, cinema and the popular arts, and draw comparisons with the literature and art of other major human catastrophies of the 20th century, including the response to the atomic bomb.

Sidra Ezrachi is Lecturer in contemporary Jewish literature at the Institute of Contemporary Jewry at the Hebrew University in Jerusalem. She has written many articles and essays on Holocaust literature including a feature article in the Yearbook of the Encyclopedia Judaica. Her book, By Words Alone: The Holocaust in Literature, was nominated for the National Jewish Book Council Award.

John Felstiner is a Professor of English at Stanford University. His most recent work on translating poetry was awarded the Commonwealth Club prize. He has written essays and poems on the Holocaust, and has been awarded fellowships from the Rockefeller Fund and the Memorial Fund for Jewish Culture to study Holocaust poetry.
